1. **WARRANT** - Author warrants that the Work is original to Author and that he or she controls the rights granted here.
2. **GRANT OF RIGHTS** - Author grants Publisher one-time World English Magazine Publication Rights in eBook and print form to the Work to be used in a magazine-style production of the Publication as a whole. These rights will be exclusive for 24 months or until Mythulu has officially released Publication, (whichever comes first) after which Author is free to place the story elsewhere. Author also grants Archival Rights in the English Language. All other rights are retained by Author.

- b. Even though Publisher intends to publish in the Publication issue above, Publisher reserves the right to publish the Work once in any issue of their choosing (“Relevant Publication Issue”) as long at the Work is published within the period of time specific in Section 5.
3. **PAYMENT** – Publisher agrees to pay Author a one-time payment of \$ _____ USD for the rights granted in this Agreement. Payment is due to Author immediately. In addition to this monetary consideration, Publisher grants Authors the following additional benefits:
- i) **Affiliate Bonus** – To encourage Author participation in marketing efforts of the Publication, Publisher agrees to pay the Author 10% of profit (after basic printing and shipping costs) for every Publication sale or subscription where the purchaser uses the Author’s unique affiliate code or visits the Publisher’s website through the Author’s unique affiliate URL. Publisher will remit affiliate bonus earnings quarterly if they are over \$5, otherwise earnings shall be remitted annually. Author WILL receive Affiliate bonuses from purchase of other Publisher Magazine publications, even if it is not the Relevant Publication Issue. This shall apply only to Publisher’s Magazine and Magazine earnings, not earnings from other products, types of publications, or services.
 - ii) **Contributor Copies of Publication** - Author will receive SIX free download codes providing electronic access to the full Relevant Publication Issue where their Work appears. If Publisher chooses to produce print versions of the Publication, Publisher will provide Author with two complimentary physical copies
 - iii) **Discounts** - After these initial at-cost copies, Author may purchase additional copies of the Relevant Publication Issue (either ebook codes or print format) for a 40% discount after cost, plus shipping.
